PAYMENT METHODS—

Payment may be made with your order or confirmed by a purchase order from your company. Terms are net 30 days.

Please have an authorized Purchase Order number. To avoid confusion in billing when a confirming follow-up Purchase Order is sent, please identify it clearly with the words: Confirmation Order—Do Not Duplicate.

Telephone orders from individuals require payment with the order using credit card, check or money order.



FOR INTERNATIONAL ORDERS—

Orders shipped outside the United States must be prepaid in U.S. Dollars or by irrevocable Letter of Credit from a U.S. correspondent bank. Assessment packages and return privileges do not apply to international orders.
